

The Conditions of the Public Competition "New Year's Competition"

1. General conditions

1.1. These Rules determine the Terms and Conditions for holding the Public Competition "New Year's Competition" (hereinafter - the Competition).

1.2. The Organizer of the Competition is Limited Liability Company "Currency Com Bel", a Company incorporated in Republic of Belarus, Company number 193130368, with registered address at 220030, Minsk city, Internatsionalnaya str., 36-1, office 724 room 2, (hereinafter for the purposes of these Conditions referred to as - Organizer).

1.3. The Organizer of the Competition sets the following socially useful goals during its holding:

- popularization of modern technologies in the information sphere that allow trading tokenized assets and other tokens, as well as making other transactions with a token.

1.4. The Competition is held in accordance with the requirements of chapter 56 of the Civil Code of the Republic of Belarus dated 07.12.1998 No. 218-3 (hereinafter for the purposes of these Conditions referred to as - the Civil Code) and is not an advertising game or promotion event. The Competition shall be held by the Organizer independently and at his own expense.

1.5. Information on holding the Competition is available on the Organizer's website <https://currency.com>. The Competition is recognized as closed, held among persons who are registered (created an account on the cryptoplatfrom (trading platform) "Currency.com" (hereinafter for the purposes of these Conditions referred to as "Crypto platform").

Terms and Conditions of Use of the Cryptoplatfrom (Trading Platform), Other Software and the Website dated July 27, 2020 (hereinafter referred to as the Terms of Use of the Cryptographic Platform (Trading Platform)), the text of which is posted on the Organizer's Website, shall apply to the Participants.

2. Terms of the Competition

2.1. The total duration of the Competition: from December 21, 2020 to January 05, 2021 inclusive.

2.2. The competitive task is performed up to 11 hours 59 minutes 59 seconds by Minsk time on December 31 2020 in accordance with the rules set forth in Section 3.

2.3. Awards for participation in the Competition will be given to Participants who took 1st to 3rd place in the list of Participants. The list of Participants who

will receive Awards, according to the conditions established in these Rules, will be formed by the Organizer on December 31 2020 at 12 hours 00 minutes 00 seconds Minsk time.

2.4. Participants who fulfill the task established in the Competition and took the places from 1-3 among other Participants will receive the corresponding notification within 5 working days from the end of the term of the Competition task, the information will also be displayed in the Participant's Currency.com Account. The title of property to tokens, stipulated in clause 4 of these Conditions, shall be transferred by the Organizer by means of crediting the relevant quantity of tokens to the Cryptoplatfrom Accounts of the Clients Participants.

3. Terms and Conditions of the Competition

3.1. Participants take part in the Competition at their own request and at their own discretion.

3.2. The Participant must comply with these conditions of the Competition use the rights granted to him to participate in the Competition in good faith and reasonably, based on the objectives of the Competition and not to abuse these Conditions and the right to participate in the Competition.

The Organizer has the right to bar the Participant from participation in the Competition or to suspend participation of the Participant in the Competition if the Participant abuses the terms of the Competition. Abuse of the terms of the Competition means the performance by the Participant of actions that, according to the subjective opinion of the Organizer, do not have a reasonable meaning, contradict the objectives of the promotion and entail the receipt by the Participant of unreasonable benefits based primarily on the technical and / or organizational features and / or conditions of the Competition.

3.3. In order to become a Participant in the Competition, you must register (create an account on the Cryptoplatfrom (or be registered on the Cryptoplatfrom) and perform Leverage-operations on the Cryptoplatfrom. In addition, the Participant shall post on his Facebook page a link to the news about the Competition, previously published on the Organizer's Facebook page.

3.4. The number of places of Participants that will receive awards for fulfilling the terms of the Competition is limited: 3 places.

4. Competition Performance Award

4.1. The order of the Participants shall be determined on the basis of the total financial result (generating income) received by the Participant during the Competition period when performing Leverage operations on the Cryptoplatfrom. Only the Participant's financial result from Leverage-operations

initiated and completed during the Competition period is taken into account. The Participant with the largest financial result from performing Leveredge-operations on the Cryptoplatfrom during the Competition is given the first place. Then the places are distributed according to the Participants depending on the results obtained by the Participants.

4.2. The Organizer presents the award set out in clause 4.3. of the Rules to the Participants recognized as winners for fulfilling the conditions set out in section 3 of the Rules.

4.3. To the winners who take from 1st to 3rd place in the list of Participants the title of property to tokens shall be transferred by the Organizer by means of crediting the relevant quantity of tokens to the Cryptoplatfrom Accounts of the Clients Participants.

The following awards have been established:

4.4. If, in accordance with the legislation, the Organizer is obliged, with regard to obtaining by the Participant under this Conditions income, to deduct and transfer to the state budget a tax, the relevant income shall be transferred to the Participant after deducting such a tax (i.e. minus the sum of the relevant tax).

5. Additional conditions

5.1. The fact of participation in the Competition implies that the Participants are familiar with and fully agree to the conditions set out in these Rules.

5.2. The Organizer shall have the right to change the terms and conditions of the Competition or to cancel the Competition within the first half of the term set for performance of the Competition task. The terms of the Competition shall be changed or cancelled by the Organizer in accordance with the provisions of Article 928 of the Civil Code.

5.3. The Organizer shall notify about the change of the terms or cancellation of the Competition by posting information on the Organizer's website <https://currency.com>.
